## **Resolution Supporting the WEDC Fab Lab Grant**

**WHEREAS**, over the course of two centuries, the manufacturing sector has come full circle with modern assembly lines incorporating technologies such as 3D printing and computer-assisted design;

**WHEREAS**, the need for skilled workers who understand mathematics, information technology and/or engineering is ever-growing;

**WHEREAS**, in keeping with our Mission to encourage competency in problem solving and critical thinking skills; to utilize technology to transform teaching and learning so students can find global opportunities for study or jobs; to prepare our students for post-secondary education or for the job market; and to jointly plan and share resources with outside entities;

WHEREAS, our current building project provides increased facilities and capacity to expand our programs;
